CHILKAT CHALLENGE TRIATHLON VOLUNTARY WAIVER, RELEASE FROM LIABILITY AND INDEMNITY AGREEMENT

Each entrant must fill out, sign, and submit this form with their application.

The Chilkat Challenge Triathlon (CCT) is an approximately 40-mile long kayak or canoe/cycling/running race through rugged and isolated territory where roads and other people may at any moment be miles away, and where dangers, including death or injury from hypothermia, drowning, bear mauling or other acts of nature, do exist. Racers must be physically and mentally fit, as well as possess back-country survival and self-rescue skills to enable self-management until help arrives. Should an injury or incident occur, racers must realize they could be up to 24 hours away from a major medical facility. Volunteer safety personnel will be patrolling the course throughout the race, however, it is impossible to be everywhere at all times so it is critical that every racer understands the risks and is prepared.

I hereby acknowledge and agree that in consideration of being permitted to participate in the CCT race, including use of boats, equipment, and motor vehicles used for travel during the event, and with the full knowledge of the risks of the activities, I HEREBY FOR MYSELF, MY HEIRS, EXECUTORS, ADMINISTRATORS AND PERSONAL REPRESENTATIVES, WAIVE, RELEASE, AND FOREVER DISCHARGE the CCT, CCT Steering Committee, the Alaska Clean Water Advocacy project, and the Earth Island Institute including all directors, volunteers, managers, agents, contractors, and employees of any of the above or any of its affiliates and any other person acting under the authority of ACWA or the CCT Steering Committee from and against all claims, actions, causes of action, costs, expenses and demands by reason of any damage, loss, death or injury to me or my property arising out of, or in connection with my participation in the CCT.

I FURTHER HEREBY ACKNOWLEDGE AND AGREE that the event may expose me to risks and hazards, some of which are inherent to the nature of the sport itself, including without limitation, the unpredictability of weather, water conditions, or other risks and hazards which may result from other causes including, without limitation, errors of human judgment. I AGREE to personally assume all risks and hazards, and I FURTHER AGREE to bear all costs for rescue or medical attention rendered to me or for my benefit, arising from the event. I understand and agree that if in any event whatsoever I require outside assistance at any time during the race that any and all costs for such removal and/or rescue shall be borne in their entirety by myself, my heirs and/or my executors as the case may be.

I ACKNOWLEDGE AND AGREE THAT I AM ULTIMATELY RESPONSIBLE FOR MY OWN SAFETY. I ACKNOWLEDGE AND AGREE THAT I HAVE READ THIS RELEASE OF LIABILITY AND INDEMNITY AGREEMENT, THAT I CLEARLY UNDERSTOOD IT AND AGREE TO ITS TERMS, AND THAT I AM FREELY AND VOLUNTARILY EXECUTING THE SAME.
